

Jetstar Instagram Promotion Terms and Conditions

- 1) Information on how to enter forms part of the terms and conditions of entry. Entry into the promotion is deemed acceptance of these terms and conditions. Headings in this document are included for ease of reference, and do not affect interpretation in any way.
- 2) The promoter is Jetstar Asia Airways Pte Ltd (BRN 200403570D) of 80 Airport Boulevard, Changi Airport Terminal 1, #03-08 Singapore 818642 (telephone number +65 6318 0888) (**Promoter**).
- 3) All references to time in this document are to the local time in Singapore, on the date stated, unless otherwise specified, and are in 24 hour format.

Duration

- 4) The promotion commences at 12noon on 3 June 2013 and closes at 12noon on 1 September 2013 (**Promotion Period**) on Jetstar Asia's Instagram.

Eligibility

- 5) Entry is open to all Jetstar Asia Instagram followers. (**Eligible Entrants**).

Entry into the promotion

- 6) To enter, Eligible Entrants must, during the Promotion Period:
 - a) Must be following @jetstarasia on Instagram
 - b) Hashtag #jetstarasiapicofweek with their inspirational travel pictures on Instagram
