Acceptance of Terms and Conditions

- These terms and conditions ("Terms and Conditions") shall apply to the 'Fly to Okinawa with Jetstar' Lucky Draw event organised by Jetstar Airways Limited and DON DON DONKI.
- 2. By registering or taking part in this Lucky Draw, you agree to be bound by these Lucky Draw Terms and Conditions and the decisions of Jetstar Airways Limited and DON DON DONKI in connection with this Lucky Draw Qualifying Period.

Duration

Prize

The Promoter reserves the right (subject to any applicable law) to cancel, terminate or modify or suspend this promotion.
